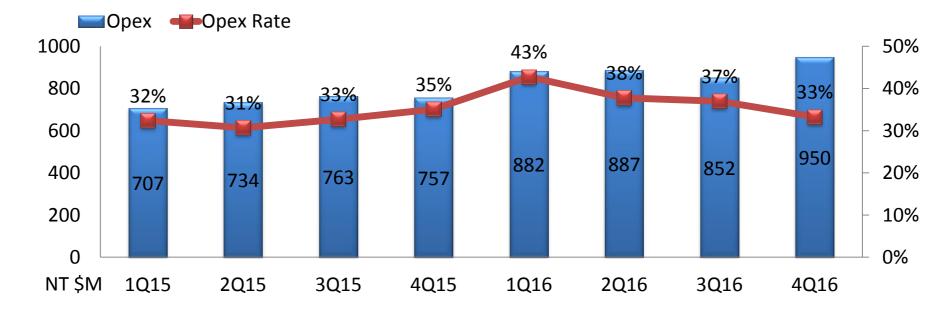

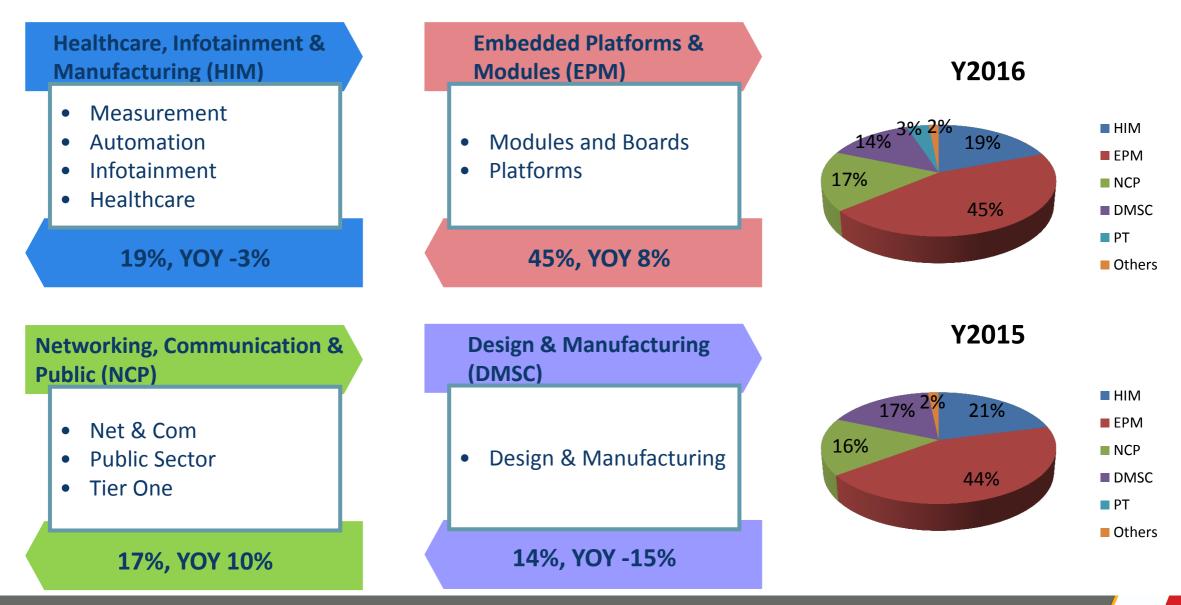

Sales breakdown by Business Unit

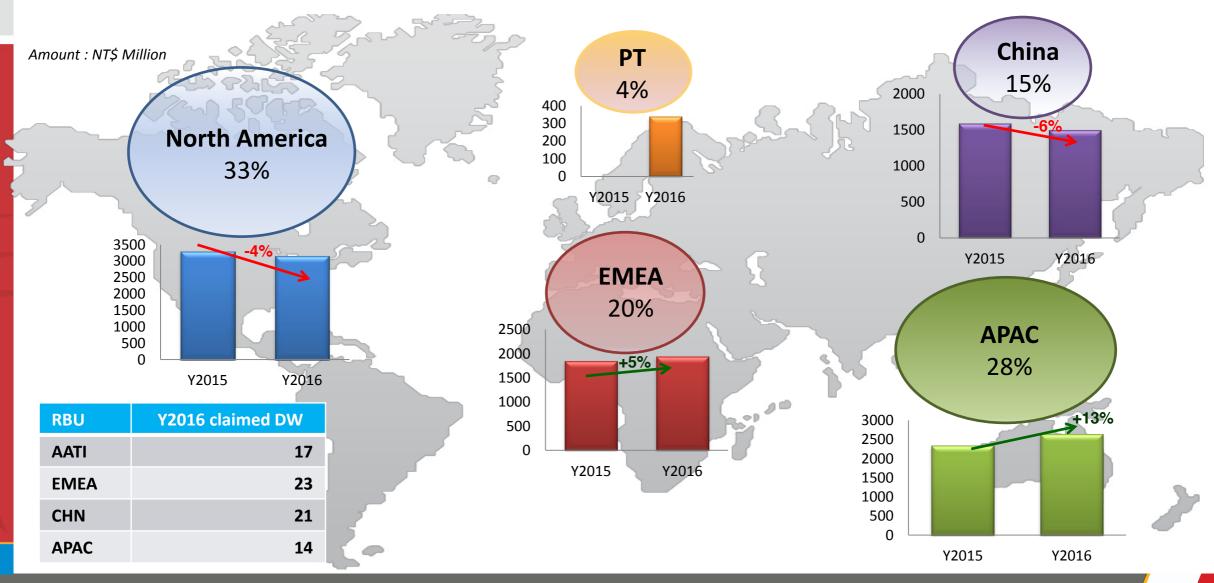
