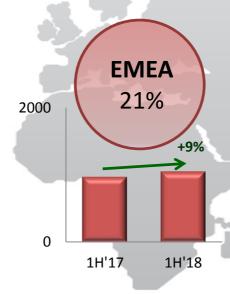
#### **Geographic Footprint & 1H'18 Claimed New DW**

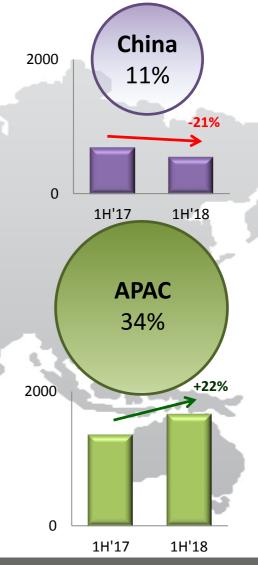

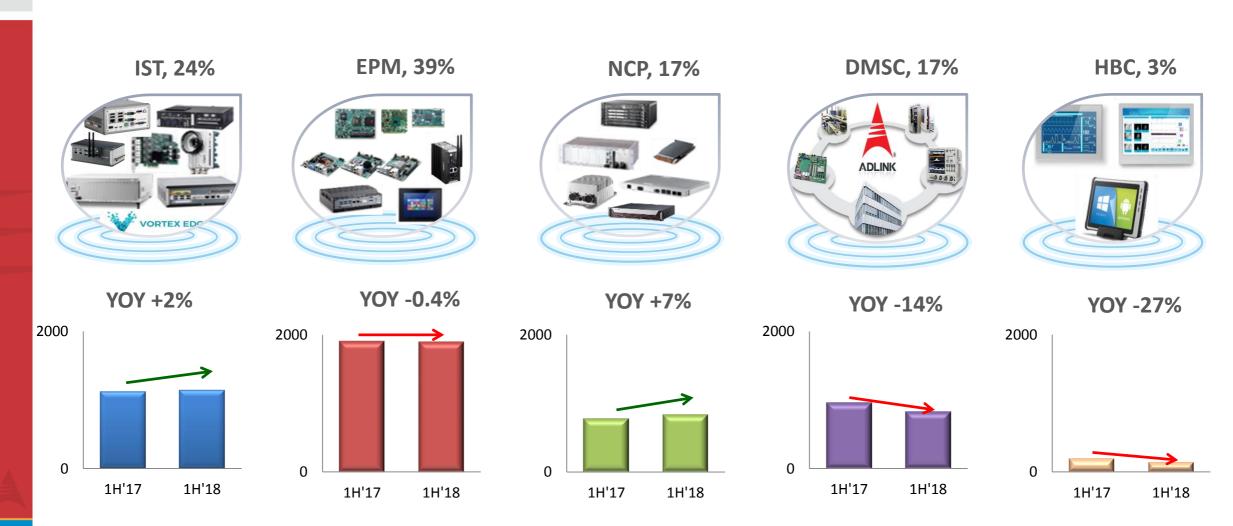






## Sales breakdown by product
